

GENERAL TERMS OF SERVICE

FOREWORD

The General Terms of Service (the "Terms") that follow refer to all Members of the Holistic Development Bureau (the "Bureau").

They are made in accordance with powers set out in the Articles of Policy of the Holistic Development Bureau and together they comprise the governing documents of the public body.

Both documents are published on the British Commonwealth official website and are provided to all new Members upon successful election.

CORPORATE STRUCTURE

The Holistic Development Bureau is a public body of the Union State of British Commonwealth.

As a public body, the Bureau is part of the union government of the British Commonwealth and is statutorily owned by The Commonwealth Crown but its Members are all such individuals that are elected to the Bureau and by virtue of the Articles of Policy are the public body.

The Bureau is as such accountable to its Members and to the union government.

The Bureau is run by the Council, which makes up the full Board of the public body, with authority to appoint any management.

The Council is led by the Council Chair, Deputy Chair and Treasurer all appointed by the union government from the current Membership.

The management includes official representatives of the Commonwealth Civil Service and the Roerich Institute of Technology as the statutory bodies that contribute to the operation of the Bureau.

The Members are elected to the Council to contribute to the strategic direction of the Bureau and serve as contact points for Members.

Council may make, alter and repeal the Terms as it thinks necessary. The Terms have to be consistent with the Articles of Policy and within the powers of Council, as set out in the Articles.

If there is any discrepancy between any of these Terms and any provisions of the Articles of Policy, the Articles of Policy shall prevail.

DEFINITIONS

In these Terms, where the context so admits, the following words and expressions shall have the following meanings:

Bureau is the Holistic Development Bureau

Council is the Board of Directors of the Bureau

The Bureau has the following principal categories of membership as per these Terms:

Standard Member is a member that is using the Bureau to self-develop.

Contributing Member is a member that is a professional participating in the development of others, and includes all membership levels below.

Full Member is a contributing member that takes an active role in development of the Bureau, and includes all membership levels below.

Where applicable, the singular shall imply the plural and the masculine shall include the feminine and vice versa.

MEMBERSHIP

Membership commences from the date specified in the Membership Acceptance Agreement and continues until termination.

Full Members do not pay a membership fee.



Standard Members pay a membership fee as per the Fee Schedule as may be published on the website of the Bureau.

If a membership fee is due, nonpayment of such after the passing of 30 days past deadline may lead to termination of membership. For annual memberships the Bureau will send a renewal notice, and if such is not paid, the Bureau may assume you no longer wish to be a Member and will cancel your membership or downgrade to a membership without membership fee.

PAYMENTS

Payments to and from the Bureau are primarily made by way of card transactions and Commonwealth direct debit and credit.

COMMITTEES

The Council may set up committees to which Members join to work on developing the Bureau.

ELECTIONS

Any citizen of the Commonwealth can apply to be elected by the Bureau. All memberships except Full Members are approved by algorithm according to the Elections Regulamin, whereas the latter needs to receive approval of the Council.

TERMINATION

A Member may be terminated, that is cease to be Member, by an expulsion decision of the Council or by resigning, with a notice of 7 days.

PROFILE

Members will be provided by HDB a profile, which features a feed of their information known as myFeed.

TIMELINE

All Members get access to a timeline of all the information they have subscribed to directly or indirectly by their actions on the website of the Bureau.

AISA

The Bureau as part of its infrastructure with the help of the Roerich Institute of Technology offers for the use of Members the Artificial Intelligence for Self-Awareness ("AISA") which proposes the optimal path for holistic development of an individual and is trained by the Members.

EARNINGS

Of the Bureau earning that concern the membership fees, 49% is distributed between the Members as per the Constituent Formula available on the website, and the remaining 51% is due to The Commonwealth Crown.

The Bureau keeps only 5% of the earning of the Members concerning services provided.

PERSONAL DATA

Your personal details will be collected, processed, stored and used by the Bureau in the course of delivering your membership, to the extent required to deliver your membership.

NON-COMPETITION

Membership in the Bureau does not prevent a Member, directly or indirectly, of participating in other platforms and organisations, as excluding any platform or organisation that directly competes with the Bureau.

LIABILITY



The Bureau shall not be liable for any damages to the Member unless it can be proven that such damages arose out of direct negligence by a person in direct or indirect employ of the Bureau.

Authority recognised in the Commonwealth.

ACTIONS AND DUE PROCESS

Any action or due process of a, or by a, Member to another Member or the Bureau shall be valid if such is authenticated by a valid Digital Identity that **JURISDICTION**

These Terms follow Commonwealth Legislation and the Commonwealth Courts shall be superior to any other in resolution of any disputes.
